Our mission remains steadfast – to serve Chicago’s highest need students, ensuring that their talent does not go wasted. We are excited to have embarked on Forward to 500, a plan for growth. By the fall of 2020 we expect to have 500 Scholars attending high school as Murphy Scholars.

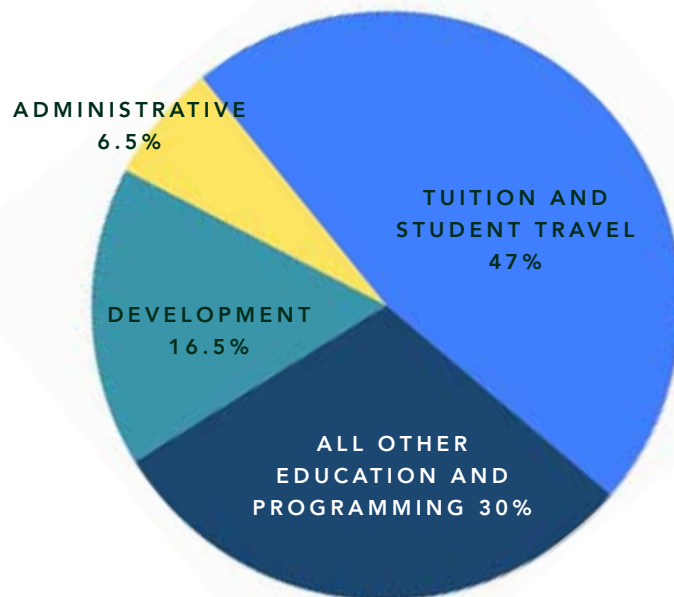
